



STUDENTS' UNION CONSTITUTION

SCHEDULE 1

Section A:

Returning Officer and Electoral System

A Returning Officer shall be appointed by the Executive Committee for each set of elections. The Returning Officer shall be responsible for the conduct of the elections, including by-elections, held under section B to G inclusive of this Schedule. The Returning Officer may only be removed from office by the Executive Committee. Elections held under Sections B to G will be conducted under the Single Transferable Vote Proportional Representation System (Electoral Act of Ireland 1923, Amendment Act 1963).

Section B:

The election of the officers of the Executive of the Union (exclusive of the Societies' Chairperson and the Clubs' Captain)

1. The term of office of the Officers shall be from July 1st to June 30th of the following year.
2. The election of the full time officers of the Union shall take place on the same day, in the second semester.
3. The election of all other officers shall take place on the same day in the second semester, (in a different week than Schedule 1.B.2 above).
4. In an election where more than one position is to be filled, a candidate may be nominated for one position only.
5. Only full members of the Union may be nominated as candidates for any elective post under this section.
6. A candidate's nomination paper must clearly specify the post for which s/he is being nominated, the candidate's name and student identity number. The form must be signed by the candidate and no less than 20 nominators. All nominators must also be full members of the Union.
7. Nomination papers must be returned to the Elections Committee no later than 5.00pm on the prescribed college day. This day shall be advertised on all Union notice boards and website(s) and shall be at least five college days

before the day of the election. Nominations must remain open for five college days.

8. Withdrawal of nominations must be received by the Returning Officer no later than 5.00pm one college day after the close of nominations.
9. The elections shall take place within ten college days following the close of nominations.
10. The Elections Committee shall, within 24 hours of the latest date for withdrawal, make available, a list of all validly nominated candidates.
11. Voting shall take place at the appropriate polling stations between the hours of 10.00am and 9.00pm on the day of the election, excepting in such cases where the Elections Committee deem unnecessary to do so. The Elections Committee shall publish the locations and arrangements of voting stations with the list of candidates.
12. All full members of the Union may vote on production of a current Student Identity Card. A ballot paper shall be issued to a voter only after his/her name has been checked with the register or s/he by any other means, been identified as a student of the University and therefore a full Union member. This is subject to Schedule 1.H.2
13. All members of the Executive Committee shall be entitled to vote whether s/he is a student or not. Notwithstanding this, only registered postgraduate students of the University shall be eligible to vote in the election of the Postgraduate Officer. This is subject to Schedule 1.H.2
14. Votes shall be cast in sealed ballot boxes.
15. Each ballot paper shall bear the name of the office contested, and in alphabetical order of surnames, the names of all validly nominated candidates.
16. Students may avail of "Remote Vote" to cast their vote online on the day of the election. To avail of remote voting, students must register to do so two days before the election. Registered remote voters will be entitled to vote online during the hours of polling. Details of remote voting will be advertised by the Elections Committee in advance of the election.
17. The ballot paper shall contain the names of all candidates. In all elections where there are any nominations, ballot papers shall include as an option the statement 'Re-open nominations', which shall be treated as a candidate and shall be the last name on the ballot appear. If the 'Re-open nominations' candidate is elected, the Returning Officer shall declare the vacancy unfilled and a new election shall be held in accordance with the provisions of this Schedule.

Section C:***By-elections of Executive Officers of the Union (exclusive of the Clubs' Captain and Societies' Chairperson)***

If any of the above posts falls vacant, a by-election shall be held according to the following procedure:

1. Upon the occurrence of a vacancy, the President of the Union shall, within seven college days, give notice to the Returning Officer.
2. Within three further college days, the Elections Committee shall cause to have the vacancy advertised on all Union noticeboards and website(s) and shall give notice of the by-election. Nominations must remain open for five college days.
3. Nomination papers must be returned to the Elections Committee not later than 5.00pm on the prescribed college day. This day shall be advertised on all Union noticeboards and website(s) and shall be at least five college days before the day of the election.
4. A candidate's nomination paper must clearly specify the post for which s/he is being nominated, their name, the candidates Student Identity Number and must be signed by the candidate and no less than 20 nominators. All nominators must also be full members of the Union.
5. The list of candidates, all of whom shall be full members of the Union, shall be made available within 24 hours of close of withdrawals.
6. The election shall take place within ten college days following the close of nominations.
7. Save as provided in paragraphs 1, 2 and 3 Section C, the procedure set out in Section B above will apply to by-elections held under this section.

Section D:***Elections of a representative of the Sports Clubs (Clubs' Captain) and the Societies (Societies' Chairperson) to the Executive Committee.***

1. The Election of the Clubs' Captain and Societies' Chairperson shall take place on the same day as the election of the Students' Union Part Time Officers (Schedule 2.B.3).
2. Each Club and Society (recognised by the University) shall be entitled to nominate one representative to cast the vote of that club or society. Each Club & Society must provide details of the person to cast their vote to the Elections Committee at least 48 hours before the opening of polls. Each representative may only represent one Club or Society. Ballot papers for the relevant position will be issued to representatives of clubs & societies by the Returning Officer. Voting shall take place in accordance with Schedule 1.B.12
3. Candidates for the position of Clubs' Captain or Societies' Chairperson must be members of the Students' Union.
4. Nomination papers will be made available by the Elections Committee.
5. In the case of Clubs' Captain, candidates must be nominated by at least three captains of clubs recognised by the University.
6. In the case of Societies Chairperson, candidates must be nominated by at least three Auditors of societies recognised by the University.
7. Nomination papers must be returned to the Elections Committee no later than 5.00pm on the prescribed college day. This day shall be advertised on all Union notice boards and website(s) and shall be at least five college days before the day of the election. Nominations must remain open for five college days.
8. Withdrawal of nominations must be received by the returning officer no later than 5.00pm on the prescribed college day. This day shall be one college day after the close of nominations.

Section E:***By-elections for representatives of the sports clubs (Clubs' Captain) or the societies (Societies' Chairperson) to the Executive***

If either of the above posts should fall vacant, a by-election shall be held according to the following procedure:

1. Upon the occurrence of a vacancy, the President of the Union shall, within three college days, give notice of the vacancy to the Returning Officer, who shall cause the vacancy to be advertised within a further twenty-four hours.
2. Nomination papers and elections shall be conducted in accordance with the procedures in Section D.

Section F:***Election of members of the Class Representative Council, other than the Executive Committee***

1. Elections to the CRC shall take place within the first four weeks of the first semester.
2. The term of office of the CRC shall be from the second week of the academic year until another CRC is elected in the subsequent academic year. Each CRC shall last for a maximum of twelve months.
3. Each academic department shall be responsible for co-ordinating the appointment of members of the CRC in each of their classes and years, other than the Executive Committee who shall be members of the CRC by virtue of Article 10(B) (i) of the constitution.
4. Departmental Groups shall appoint a Class Rep. each to the Staff-Student Liaison Committee within each faculty.
5. Candidates for membership of the CRC shall be full members of the Union and shall be members of the class which they represent.
6. This section should be read in accordance with CA/STD/M23/4 passed by Academic Council Standing Committee on June 9th, 2001.

Section G:

Publicity in connection with Elections and By-Elections

1. A candidate may only display posters etc. in such places as may be permitted by the University Postering Policy. Candidates must not display these items outside of University grounds.
2. Candidates may not distribute any gifts, promotional products, vouchers, food items, passes or tickets to promote their candidature. Only printed material and personalised campaign T Shirts may be used. Competitions the awarding of prizes are also prohibited.
3. Sponsorship or endorsement by a third party (with the exception of promotion by another nominated candidate) is not permitted in any form by candidates or persons associated with a candidate's campaign. Promotional material must not include branding, names or logos of any third party (with the exception of promotion of another nominated candidate).
4. A candidate shall not distribute, nor cause to have distributed, any promotional material until 6:00pm on the Sunday before the election. Promotion via any websites is also prohibited until that time.
5. No canvassing or any like activity shall take place in the immediate vicinity of the ballot box as determined by the Returning Officer.
6. Candidates may not use animals to promote their campaign.
7. Each candidate, or their nominee, must attend a daily meeting with the Elections Committee for the duration of the election campaign.
8. If complaints are received by the Elections Committee regarding the behaviour of a candidate, the Elections Committee shall have the deciding authority, after issuing the candidate with a warning, to deem that candidate ineligible for election to any post on the Executive Committee.
9. Any candidate who does not comply with the provisions of this Section of the Constitution shall be deemed ineligible for election to any post on the Executive Committee of the Union for that set of elections.
10. The Elections Committee will interpret the Election Regulations as they see fit and the decision of the Elections Committee is final.

Section H

Elections of College Convenors

1. There shall be five College Convenors:
 - i. Convenor of the College of Engineering & Informatics
 - ii. Convenor of the College of Arts, Social Sciences, and Celtic Studies
 - iii. Convenor of the College of Science
 - iv. Convenor of the College of Business, Public Policy & Law
 - v. Convenor of the College of Medicine, Nursing & Health Science
2. Only members who are registered in a particular College will be eligible to vote in the election of that College's Convenor.
3. Nominations and elections of College Convenors will be carried in accordance with Schedule 1.B.

Section I

Election of the Students' Union Council Chairperson

1. The SU Council Chairperson shall be elected at the last SU Council of the academic year.
2. Nominations for the position of SU Council Chairperson will be advertised at the SU Council before the last SU Council meeting of the academic year. Nomination papers will be made available by the Elections Committee. Candidates must be nominated by at least five registered class representatives.
3. Only registered class representatives will be eligible for nomination.
4. Only registered class representatives shall be eligible to vote.
5. The election shall be run by the Elections Committee.
